- Maximize impact with no net cost: Earn up to 90% tax credits while supporting youth.

How EITC Works

Step 1: Apply

- Businesses apply to the Pennsylvania
 Department of Community and Economic
 Development (DCED).
- Applications open July 1 each year (firstcome, first-served).

Step 2: Designate

 Choose Philadelphia Youth Network as the recipient of your EITC-approved contributions.

Step 3: Invest

• Redirect up to **75% of your state tax liability** (or **90% for a two-year commitment**).

Step 4: Impact

 Watch your investment create measurable outcomes for hundreds of Philadelphia youth.





Frequently Asked Questions

Who qualifies for EITC?

Businesses authorized to pay taxes in PA (corporate net income tax, capital stock tax, bank shares tax, etc.).

How much can be credited?

Up to 75% of your contribution, or 90% if you commit for two years.

How do we apply?

Businesses apply online through the PA Department of Community and Economic Development (DCED). Early application is key credits are distributed on a first-come, first-served basis.

Can we support more than one nonprofit?

Yes. Businesses can divide credits among multiple approved organizations, including PYN.
